Website Terms of Use

Effective as of 8/15/2016

1. Basic Service User and Subscribed Basic User

As a user of our public websites, www.etfmi.com, www.axmomentum.com, www.blockchainmomentum.com you agree and acknowledge that you are not a client of the Registered Investment Advisor, ETF Momentum Investing, LLC (ETFMI), AX Momentum, LP or Blockchain Momentum, LP (collectively "The Firms").
